**3.1 YWCA Niagara Region Anti-Human Trafficking Funding Proposal with the Ministry of Children, Community and Social Services**

Elisabeth Zimmermann, Executive Director, YWCA Niagara Region, presented information respecting YWCA Niagara Anti-Human Trafficking Funding Proposal with the Ministry of Children Community and Social Services. Topics of the presentation included:

WHEREAS Niagara experiences a high level of human trafficking due to it being a US border community, easily accessible from the GTA and a tourism center;

WHEREAS the profoundly negative effects of human trafficking not only dramatically affects the victims, but is also felt throughout the entire Niagara region, as it funds organized crime and consumes countless public resources;

WHEREAS the YWCA has successfully assumed a leadership role in Niagara by initiating and coordinating the development of the Anti-Human Trafficking Emergency Response Protocol with over a dozen community partners;

WHEREAS the YWCA continues to lead the fight against human trafficking in Niagara;

WHEREAS the Regional Municipality of Niagara and the YWCA continue to enjoy a productive partnership in the fight against human trafficking;

WHEREAS the YWCA has submitted a formal funding application to the Province of Ontario to provide the necessary resources to operate a 6-bed emergency crisis housing project to serve youth between the ages of 16-24 who are escaping human trafficking;

WHEREAS the YWCA's project will provide those exiting a human trafficking situation with the necessary skills to build the resiliency to achieve a long-term exit; and

WHEREAS the YWCA's project directly aligns with Council strategic plan to build safe and inclusive neighbourhoods;

NOW THEREFORE BE IT RESOLVED:

1. That the Regional Municipality of Niagara formally **ENDORSE AND SUPPORT** the YWCA's application to the Province of Ontario for the necessary funds to operate the 6-bed emergency crisis housing project; and
2. That the Regional Chair **BE DIRECTED** to send a letter of support to the appropriate provincial ministries that adequately expresses Council's support for the YWCA's application.
