13. MOTIONS

13.1 <u>Selection of Members to the Niagara Peninsula Conservation Authority</u> (NPCA) Board of Directors

Moved by Councillor Edgar Seconded by Councillor Marshall

WHEREAS the Niagara Peninsula Conservation Authority (NPCA) is a Provincially mandated agency operating in the Region of Niagara, Haldimand County and the City of Hamilton, funded largely by the Region of Niagara;

WHEREAS the each of Niagara's 12 Cities, Towns and Township are collectors and contributors of public funds to the Region of Niagara, and, therefore, a contributor to the NPCA's funding;

WHEREAS the people of all municipalities represented on the NPCA Board deserve openness and accountability relating to how their tax dollars are being spent, how effectively our natural environment is being protected, and how representatives to the NPCA Board are appointed;

WHEREAS currently, 11 of the 12 Niagara members of the NPCA Board are municipal politicians who may not have the necessary conservation and environmental expertise suited to effectively serve on this important Board;

WHEREAS for the City of Hamilton, it has been the practice of their city council to appoint citizen representatives to the NPCA Board, thus highlighting the importance of the ability to provide appropriate knowledge, experience and expertise to the Board and establishing a precedent to support citizen appointment to the NPCA;

WHEREAS the Auditor General, in her September 27, 2018 report to the Ontario Legislative Assembly, recommended that "members of the Niagara Peninsula Conservation Authority (NPCA) Board of Directors should collectively have the skills, experience and training necessary to oversee the NPCA's activities effectively" and that the "NPCA's funding municipalities [should] ensure that their Board appointment processes consider skills and experience requirements";

WHEREAS the informal, past practice of the Niagara Regional Council has been to offer a single appointment from each of the twelve local municipalities by: first, offering appointment to the Regional Councillor(s) or Mayor of the local municipality; and, second by a process that defaults to the local municipal Councillors; and then, finally, to citizen representation; (please see attached description from NPCA website); and

WHEREAS the majority of Council's across the Niagara Peninsula recently supported a formal appointment protocol that allows the local municipalities to seek applications for appointment to the NPCA Board and that a recommendation for appointment then be subsequently provided to the Region by the local municipalities.

NOW THEREFORE BE IT RESOLVED:

That Regional Council **ESTABLISH** a formal process for appointments to the Niagara Peninsula Conservation Authority Board to request and permit each of Niagara's local municipalities to publicly advertise and make recommendations for appointment of a qualified and independent citizen with appropriate skills and expertise to represent their respective municipalities, to take effect following the 2018 municipal election, or immediately should a vacancy on the NPCA Board of Directors occur; and

That a copy of this resolution **BE FORWARDED** to the Auditor General of Ontario; Minister of Natural Resources and Forestry; the current NPCA Board of Directors; Niagara MPPs; the City of Hamilton; Haldimand County; and Niagara Local Area Municipalities for information.

- Secured Niagara as the Host Region for the 2021 Canada Summer Games

- Created a matrix to measure Council progress on strategic priorities.
 The results are clear:
- We are rated as one of Ontario's most competitive centres
- We were the first Foreign Trade Zone Point in Ontario
- There was an unprecedented \$1.52 Billion industrial and commercial construction over the term and \$1.4 Billion in 2017 construction.
- Listed as the top upper tier municipality on the 2017 Open Cities Index, based on the openness and transparency of municipal data to the public
- Created many new affordable housing units + invested millions in new social housing.
- Kept taxes at a low 1.47% average, below inflation over the term, with a tax freeze in 2016

I'm grateful for this opportunity to have worked with each of you to move Niagara forward. We have laid some important groundwork that will enable the next term of Council to build on these projects and enhance life for the people and businesses of Niagara.

You work diligently to deliver on Council's Strategic Plan, and implement the decisions of council, within Council's budget... and that's no easy task. Thank you for your commitment to our organization and to our customers, the people of Niagara.

5. REVIEW OF PROCESS FOR APPOINTMENT OF REGIONAL CHAIR

The Regional Clerk explained that Regional Council would be following the procedure outlined in the Region's Procedural By-law and past practice respecting the election of the Regional Chair.

The Regional Clerk advised those in attendance that on June 20, 2013, Council adopted a policy that provides only members of Regional Council may be nominated for the position of Regional Chair.

Scrutineers must be appointed for the counting of any ballots for the election of the Regional Chair.

The Regional Clerk explained that nomination and consent forms have been placed at each member's desk. Nominations must be in writing, moved and seconded by members of Council and have the written consent of the nominee attached.

The names of the nominees will be displayed on the screens in the Chamber.

After the nominations are closed, a speakers' list will be created listing the nominees in alphabetical order and each nominee will be granted five minutes to address Council.

The voting for the election of the Chair will begin after the speeches of the nominees. A ballot will be delivered to each member of Council. The election of the Chair will be conducted by secret ballot as permitted by the *Municipal Act*, 2001, and the Region's Procedural By-law.

Members are to print only the name of their preferred candidate for the office of Regional Chair in the space provided on the ballot and fold the ballot; they are not to print their own names anywhere on the ballot.

If a ballot is inadvertently spoiled, staff will retrieve the spoiled ballot and provide a replacement ballot.

Staff will collect the folded ballots and take them to Committee Room 4 where the Scrutineers will count the ballots.

The Scrutineers will deliver a certified tally sheet of the results to the Regional Clerk. The results will be announced by the Regional Clerk and displayed on the overhead screens in the Council Chamber.

To be elected as Regional Chair, a candidate must obtain the concurring votes of the majority of the members present.

If there are more than two nominees and if, upon the vote, no nominee receives the majority required for election, the name of the nominee receiving the least number of votes shall be dropped and another vote shall be conducted.

If two or more nominees are tied with the least number of votes, a special vote will be taken to decide which one of the tied nominees' names will be dropped from the list of names.

Such voting will continue until a nominee receives the majority required for election or it becomes apparent by reason of a tied vote that no nominee can be elected.

POLICY STATEMENT

It is the intent of this policy to delineate the conditions under which the Region will request a dedication of land for widening regional road allowances. This policy will be applied when considering road widening as part of reconstruction or refurbishment of existing highways, or otherwise required in the opinion of the Commissioner of Public Works to accommodate moving traffic, parking, pedestrians, utilities and access to adjacent properties in accordance with the Philosophy of Land Dedication described herein. It shall further be applied when considering development applications adjacent to regional roads for plans of subdivision, condominiums, severances, rezonings, site plans, variances and Niagara Escarpment Commission development applications.

RATIONALE FOR LAND DEDICATION POLICIES FOR ROAD WIDENING PURPOSES

Land dedication requests are made in an attempt by the Region to reduce the costs of acquiring land for road widening purposes. In approving development along regional roads or in approving zoning changes which will permit development to occur, the Region enables property owners to develop their land but in turn acquires certain financial obligations. These financial commitments may result from the need to provide sewer and water services, and new or wider roads (as well as other commitments which are part of municipal and regional government). Thus the Region, in requesting land dedications, recognizes the private benefits associated with developments it approves and, in turn, attempts to reduce public expenditures associated with such developments. In this way, a portion of the burden is placed upon the beneficiary rather than all on the general public.

PHILOSOPHY OF LAND DEDICATION

Three general principles will be applied in assessing the need for land dedication for road widening purposes.

1. Role of the Roadways in the Region's Transportation System

Traditionally road rights of way are designed to accommodate moving traffic, parking, pedestrians, utilities and access to adjacent properties. The adjacent section of roadway to a development will be evaluated as to its present condition and ability to provide the above functions. The adjacent roadway will also be evaluated as to how these functions can be provided in the future when the projected volumes on the Region's transportation system are realized. The adjacent section will then be reviewed and the necessary widening will be identified.

2. <u>Impact of Development on a Roadway</u>

Development adjacent to any roadway usually has some impact on how the roadway functions because of the demand for additional utilities, increased pedestrian use or access. Minor variances usually do not affect traffic volumes. Severance and rezoning applications will vary in their effect, depending on whether or not additional buildings or higher development densities are to be expected. Subdivisions usually have a major impact on the adjacent road section in that there is a major change in the land use. The impact of the development of adjacent roadway will be evaluated from the point of view of access, increased traffic, and provision of utilities in order to identify the widening required.

3. Determining Width of Road Widening

The Region's request for a road widening will be fair and consistent and conform to the Region's Policy Plan Amendment 106 for Regional road allowances. Generally, for most Regional roads the request will require the transfer of equal and sufficient land from both sides of the road to establish an overall width of 26.212 metres (86.0 feet) measured 13.106 metres (43.0 feet) from the centre line of the original road allowance.

In established urban areas where the majority of existing buildings are located close to the road allowance (ie. downtown commercial areas), the request for a widening will attempt to establish a uniform road allowance. Because of physical and practical constraints, the uniform width may vary in most cases from 10.058 metres (33.0 feet) to 13.106 metres (43.0 feet) (the preferred distance) from the centre line of the road allowance.

New development such as commercial, residential, industrial or institutional may require dedication of additional and uneven widening to permit the construction of turning lanes,

sidewalk and utilities to service the new development.

In the case of an intersecting road, the Region may require the dedication of a triangular widening for traffic design, sidewalk or utility purposes. The side of the triangular shall not exceed 15 metres (49.213 feet) in a rural area and 4.5 metres (14.764 feet) in an urban area. Some variations could occur in unusual circumstances (as per Policy Plan Amendment 106).

LAND DEDICATION FOR ROAD WIDENING PURPOSES

Policies with respect to each type of, road widening based on the potential source of the lands, are as follows:

1. Subdivisions and Condominiums

The Regional Municipality of Niagara will request dedication of all lands necessary for improvements to the abutting regional roads and for the provision of future regional roads as a condition for approval of draft plan of subdivision and condominium.

2. Severances

The Regional Municipality of Niagara will request the Land Division Committee to include, as a condition of severance approval, a dedication of all lands necessary for improvements to the abutting regional road for any parcel on which new or additional development can occur as a result of the severance, and on regional roads which need to be widened within the foreseeable future. The request for a gratuitous widening for any one severance application will not exceed 500 feet in length across the frontage abutting the regional road allowance.

3. Rezoning By-laws and Site Plans

The Regional Municipality of Niagara will request that provision be made in any development agreement between the area municipalities and the owner for the dedications of all lands necessary for improvement to abutting regional roads, provided the application would allow new or additional development and that the regional road will need to be widened within the foreseeable future.

4. Minor Variance

The Regional Municipality of Niagara will request the Committees of Adjustment of the local

municipalities to request, as a condition of minor variance approval, a dedication of all land necessary for improvements to the abutting regional road <u>only</u> where it is felt that the minor variance will adversely affect the operation and safety of the regional road or will permit a significant increase in development.

5. Niagara Escarpment <u>Development Applications</u>

The Regional Municipality of Niagara will request the Niagara Escarpment Commission to include, as a condition of approval of a development permit with the Niagara Escarpment development control area, a dedication of all lands necessary for improvements to the abutting regional roads, provided the application would allow new or additional development and provided the regional road will need to be widened within the foreseeable future. This request for a gratuitous widening will not exceed 500 feet in length across the frontage abutting the regional road allowance.

6. Other Land Acquisitions

The Regional Municipality of Niagara shall, when undertaking construction or refurbishment of roads or upon discovery of specific needs, consider and apply best industry practices in road design while at all times maximizing value for taxpayers. If, as a result of application of best practices and the principles set forth in this Policy, a road widening is in the opinion of the Commissioner of Public Works, desirable; the lands needed for the widening exist within the stock of land already owned by The Regional Municipality of Niagara and available for that use; or such lands can be acquired with funds budgeted for related road works, then a by-law to effect such widening will be prepared and submitted to Council for consideration.

ACCEPTANCE AND DEDICATION

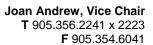
To minimize the number of reports to be dealt with at the Committee level, the Director of Legal & Court Services will accept these road widenings and/or reserves as a procedural matter not requiring a separate report to Committee. Dedication of road widenings will be done by by-law which the Director of Legal & Court Services will periodically submit to Council.

I have the pleasure of writing to you on behalf of The Niagara Parks Commission regarding The Regional Municipality of Niagara's representative to the Commission's Board.

Subsection 3(2) of the Niagara Parks Act, R.S.O. 1990, c. N.3, provides for the composition of the Commission's Board, specifically that it "...shall be composed of not fewer than ten and not more than twelve members appointed by the Lieutenant Governor in Council of whom...one member shall be a member of the council of The Regional Municipality of Niagara and shall be appointed annually upon the recommendation of such council."

I am writing this letter to formally express my support for Positive Living Niagara's application for a permanent overdose prevention site in Niagara.

Between 2016 and 2017, Niagara saw a 335 percent increase in opioid overdoses. It became immediately clear that Niagara needed a comprehensive public health strategy to tackle this growing epidemic. The temporary overdose prevention site unanimously approved by St. Catharines City Council was the first step in combatting this crisis, and the second step is ensuring this site be allowed to operate permanently.

If we are to meaningfully tackle the opioid crisis in Niagara, it requires a permanent facility, staffed with mental health and addictions counsellors, EMS workers, and public health professionals. This facility will connect those struggling with addiction to vital resources for housing, counselling, mental health and addictions support, all while preventing overdoses in the process. In just a few days of operation, I am confident that Positive Living Niagara has already created such a facility, and for that reason I am happy to endorse their proposal for a permanent overdose prevention site.

Every drug overdose is a preventable death. Elected representatives have a duty to ensure that we are doing everything in our power to stop these lives from being lost. On December 6, 2018, the Province released the first draft of *Bill 66, Restoring Ontario's Competitiveness Act, 2018*.

Among broad amendments to various statutes, Bill 66 contemplates an amendment to the *Planning Act, 1990*. The Region's comments below relate only to the proposed *Planning Act, 1990* changes and not the other statues proposed for amendment.

Bill 66 would permit local municipalities to pass an "open-for-business by-law". This by-law could only be passed where there's a Council resolution and where it has approval from the Minister. What the Minister may permit in that by-law is limited; those limits will be identified at a later time.

An open-for-business by-law would not be subject to certain Provincial Plans and other legislation, but, *critically*, will be subject to other requirements of the Minister and the local municipalities.

Municipalities have latitude to impose conditions. As one of several examples, the openfor-business by-law would be subject to "Any requirement that is reasonable for and related to the appropriate use of the land and that the municipality considers necessary for the protection of public health and safety" (s.34.1(8)4).

Enacting an open-for-business by-law is entirely at the discretion of local municipalities; there is no requirement to do so.

Bill 66 applies throughout the Province and is not specific to the Greenbelt Plan area. Open-for-business by-laws will not be used to undermine key components of the Greenbelt Plan. The Region remains committed to the protection of natural features, provincially significant wetlands and agricultural lands. Open-for-business by-laws will not alter the Region's established growth strategy that includes limiting urban sprawl and protecting source water.

If the legislation proceeds, we anticipate a cooperative approach between the Region and local municipalities, to identify how an open-for-business by-law may work in their

municipality. These by-laws may be used to increase the Region's competitiveness in attracting new businesses and contributing to the economic prosperity of the area.

For instance, we may be able to explore opportunities in the Gateway Economic Zone (outside the Greenbelt Plan area) for an open-for-business by-law that provides streamlined approvals for key industries identified by the municipalities.

Subject: 2019 Legislative Schedule of Regular Meetings

Report to: Regional Council

Report date: Thursday, December 13, 2018

Recommendations

That one of the three options of the 2019 Legislative Schedule of Regular Meetings (attached as Appendix 1, 2 and 3) **BE APPROVED** by Regional Council.

Key Facts

- The purpose of this report is to seek Council's approval of a 2019 Legislative Schedule for regular meetings.
- In November 2017, the Corporate Services Committee referred option 3 (Standing Committees and Council meetings held on three (3) consecutive Thursdays on a monthly basis) as a scheduling option to be considered by the new Council.
- Staff are supportive of moving to a monthly schedule of meetings.

Financial Considerations

Depending on the option selected by Council, there may be a small amount of savings realized due to the reduction of the number of meetings being held.

Analysis

At the Corporate Services Committee meeting held on November 8, 2017, Committee referred consideration of changing the legislative schedule to hold Standing Committees and Council meetings to three (3) consecutive Thursdays on a monthly basis to the next term of Council. Given the request to have this option considered by the new term of Council, staff are presenting three options of legislative calendars. In the proposed options staff have included meetings in the month of August.

Option 1 proposes a legislative schedule that Council has followed for many years with a total of 30 days of Standing Committee meetings and 15 Regional Council meetings (Standing Committees would be held on Tuesdays and Wednesdays during regular working hours and Council meetings on Thursday evenings on a three (3) week rotation).

Option 2 proposes a similar schedule as Option 1; however, Committee and Council meetings would be scheduled on a monthly basis rather than a three (3) week rotation.

This results in having 24 days of Standing Committee meetings and 12 Regional Council meetings.

Option 3 proposes a change in the traditional meeting schedule such that Standing Committees and Council meetings would be held on three (3) consecutive Thursdays. It also proposes monthly meetings rather than the traditional three (3) week rotation. As in Option 2 this results in having 24 days of Standing Committee meeting and 12 Regional Council meetings.

If Council were to choose option 3, given the number of Budget Review Committee of the Whole meetings scheduled during January and February, this option would not be able to be implemented until March. In addition due to the proximity to Christmas, the month of December does not allow for meetings to follow this format.

Staff have reviewed other upper-tier municipal legislative schedules (York, Waterloo, Durham and Halton) and have identified that while there is no preference on any one meeting schedule, what is consistent is that they meet on a monthly basis.

Staff have discussed the three legislative meeting schedule options presented in this report for consideration and generally agree that Option 2 would allow staff the ability to provide Council Members with improved service delivery by having additional time between meetings to prepare the necessary reports and documents for consideration. The additional time should also assist with the requirement to add addendum agendas to agendas.

Alternatives Reviewed

Staff have reviewed the three options and have provided alternatives for Council's consideration.

Relationship to Council Strategic Priorities

The three options demonstrate Council's strategic priorities of advancing organizational excellence and doing business different.

Recommendations

That one of the three options of the 2018 Legislative Schedule of Regular Meetings (attached as Appendix 1, 2 and 3) **BE APPROVED** by the Corporate Services Committee.

Key Facts

- The Calendar of Meetings for Regional Council and its Standing committees for the forthcoming year is approved by Council each fall.
- The purpose of the report is to seek Committee approval for a 2018 Legislative Schedule that will be presented to Council for approval.
- Staff have thoroughly discussed the three legislative meeting schedule options
 presented in this report for Committee consideration and it was generally agreed that
 Option 2 will provide staff the ability to provide Council Members with improved
 service delivery by allowing for additional time between meetings to prepare the
 necessary reports and documents for Council consideration.

Financial Considerations

Depending on the option selected, there may be a small amount of savings realized due to the reduction of the number of meetings being held.

Analysis

Option 1 proposes what is considered the normal Legislative Schedule that Council has followed for many years with a total of 24 days of Standing Committee meetings and 15 Regional Council meetings (including the Inaugural). Standing Committees would be held on Tuesdays and Wednesdays during regular working hours and Council Meetings on Thursdays on a three (3) week rotation. Please note that since 2018 is an election year, Standing Committee Meetings normally held in September, October, November and December have not been scheduled as past practice during election years.

Option 2 proposes a similar schedule as Option 1; however, Committee and Council meetings would be scheduled on a monthly basis rather than a three (3) week rotation. This results in having 16 days of Standing Committee meetings and 11 Regional Council meetings (including the Inaugural). As previously stated, since 2018 being an election year, Standing Committee Meetings normally held in September, October,

November and December have not been scheduled as past practice during election years.

Option 3 proposes a change in the traditional meeting schedule such that Standing Committees and Council meetings would be held on three (3) consecutive Thursdays. It also proposes monthly meetings rather than the traditional three (3) week rotation. As in Option 2 this results in having 16 days of Standing Committee meeting and 11 Regional Council meetings (including the Inaugural).

Both Options 2 and 3 would result in a slight reduction in costs associated with these meetings.

Staff have reviewed other upper-tier municipal legislative schedules (York, Waterloo, Durham and Halton) and have identified that while there is no preference on any one meeting schedule, what is consistent is that they meet on a monthly basis.

Staff have thoroughly discussed the three legislative meeting schedule options presented in this report for Committee consideration and it was generally agreed that Option 2 would allow staff the ability to provide Council Members with improved service delivery by having additional time between meetings to prepare the necessary reports and documents for Council consideration

Alternatives Reviewed

As described above.

RECOMMENDATION

That the NRH Board of Directors **RECOMMEND** to Council for **APPROVAL**, the **REAPPOINTMENT** of James Hyatt, Betty Ann Baker and Karen Blackley, for another year, until March 30, 2020.

PURPOSE OF THE REPORT

To seek Board recommendation on the reappointment of those Members whose terms expire on March 30, 2019.

KEY FACTS:

- Under the current By-Law #1 three (3) of the nine (9) Directors are required to retire from the Board each year; the five (5) Councillor Directors are appointed for four (4) year terms.
- Change to the governance structure presents problems for a rotating board.
- Due to Municipal elections, the Board will be losing at least three Councillor Directors.
- The terms of three of the four new Community Representatives expire on March 30, 2019.
- It would be beneficial to maintain consistency by reappointing the three experienced Directors whose terms expire on March 30, 2019.
- Bios provided in Appendix A

REPORT

The recruitment of new Community members is a lengthily process.

NRH and Legal staff require time to explore options to solve the difficulties associated with three (3) of the four community directors being required to retire each year.

In the past, compliance with the rotation requirement was not difficult; all non-Councillor Directors were usually appointed for 4-year terms, as were the Councillor Directors. See example in the chart below:

The illustrated rotation schedule does not work out for a nine (9) Director Board. Consistent terms for all Directors are not possible, as the Councillor Directors have a 4-year term, leaving only four (4) Directors to cover the rotation; three (3) of the four (4) Community Directors must retire each year. Staff anticipate bringing a recommendation forward at a future meeting to remedy this issue.

It is recommended that the Board continue its practice of reviewing the performance of directors who are eligible for reappointment. The results of the review are made known to the respective Directors. If successful, the Directors interested in reappointment, must submit an Expression of Interest to the Clerk's office according to the process outlined in Appendix B.

Evaluation Criteria

At its May 20, 2005 meeting (Report #05-36-5.5) the Board approved the evaluation criteria for assessing Director performance. These criteria were reviewed at the June 29, 2012 Board meeting (Report #12-113-3.4. Board and Director Performance) for relevance. All of the original criteria were reaffirmed with additional clarification related to meeting attendance and contribution to other committees as follows:

1. Meeting attendance

80% attendance at all meetings with exceptions recognized for illness, family matters, vacations and meetings held outside regular schedule.

2. Duration

In attendance for the entire meeting with exceptions recognized for meetings running past scheduled end time.

3. Contribution to other committees

Consideration should be given if the Director in question participates on any of the standing or ad hoc committees of the Board including Advisory Groups. It was agreed at the June Board meeting that this should be provided for information purposes only.

4. Active participation

The Director should contribute to each meeting through discussion and questions

5. Visionary

Although difficult to measure, consideration should be given if a Director is visionary and can add to discussions that move the Board and the Corporation forward.

Appendix B

REAPPOINTMENTS OF RETIRING DIRECTORS

NRH's By-Law #1, Section 3.01, Appointment and Election of Directors states:

Directors shall be appointed or elected as appropriate for a term of up to four (4) years. At the end of the four (4) year term, any Retiring Director may be reappointed or elected for consecutive terms up to a maximum of twelve (12) consecutive years but shall not thereafter be appointed or elected to the board again for at least one (1) year after the conclusion of his/her twelve (12) years of consecutive service.

Process for Reappointments of Retiring Directors:

- 1) The Chair of the NRH Board contacts the NRH Directors who are up for reappointment to see if they would like to renew for another term.
- 2) The Board reviews the performance of each Director who is being considered for reappointment and based on this review the Board determines whether they can support that particular Director for reappointment.
- 3) The results of the Board's voting are provided to the Chair who then advises each Director of the results.
- 4) The successful Directors then submit an Expression of Interest letter to Clerk's Office for reappointment.
- 5) The Chair provides the Clerk's office with a list of the recommended reappointments.
- 6) A confidential report is submitted prepared to Regional Council to approve the reappointment of the recommended Directors for Membership.
- 7) The approved reappointments are announced publically at Regional Council.
- 8) The Clerk's Office then contacts the Chair with the Council decision and the need for a Members' meeting.
- 9) The Clerk advises each Director of their successful or unsuccessful reappointment.
- 10) A Members meeting is held and a formal vote taken to approve the reappointment.

At the Inaugural meeting of Regional Council held on December 6, 2018, Council declared the seat held by Regional Councillor Jim Bradley vacant as a result of his election to the Regional Chair's position.

Council also adopted a resolution requesting that the Council of the City of St. Catharines advise Regional Council of its preferred method of filling the vacancy on Regional Council.

Council is now in receipt of a resolution of St. Catharines Council advising that it recommends Mr. Kelly Edgar be appointed to fill the vacant seat of Regional Councillor for the City of St. Catharines for the 2018-2022 term of council.

Regional Council has a policy (C-RC-002) that, in the event of a vacancy in the Office of Regional Councillor in any municipality in Niagara Region (except in Wainfleet, where said vacancy would coincide with a vacancy in the Office of the Mayor):

- Regional Council shall request the local municipality to advise the Region of their recommendation on whether a qualified elector should be appointed or if a by-election should be held; and
- 2. Regional Council would approve the recommendation of the local municipality provided it was in compliance with all provisions in the *Municipal Act* and the *Municipal Elections Act*.

In accordance with Policy C-RC-002 it is recommended that Council adopt the following motion at the Regional Council meeting on December 13, 2018:

WHEREAS Regional Council had requested and has received the recommendation from the Council of City of St. Catharines with respect to the filling of the vacant seat on Regional Council with the appointment of Kelly Edgar;

WHEREAS Kelly Edgar has consented to accept the office of Regional Councillor if appointed.

Recommendations

- That, in accordance with subsection 2.4 of Niagara Region's Procedural By-law, the rules of procedure, specifically subsection 24.6 (c), respecting the Appointment of Acting Chairs and Co-Chairs for the Standing Committees, BE SUSPENDED temporarily to dispense with the appointment of Acting Chair(s) and Co-Chairs for the Standing Committees until the appointment of Standing Committee Chairs and Co-Chairs;
- 2. That the Regional Chair **BE AUTHORIZED** to act as a Standing Committee Chair until such time as the Standing Committee Chairs are appointed; and
- 3. That Regional Council **APPROVE** and **COMMENCE** the appointment process for Regional representatives to committees, agencies, boards and commissions for the 2018-2022 Term of Council in accordance with the process outlined in Appendix I of Report GM 21-2018.

Key Facts

- Council must appoint members as representatives to committees, agencies, boards and commissions
- There is no formal policy and related procedure surrounding the appointment process for Regional representatives to committees, agencies, boards and commissions
- The Procedural By-law provides that the principal business of the Council meeting held the week after the inaugural meeting shall consist of the appointment of Acting Chair(s) until the appointment of the Chairs and Co-Chairs of standing committees is conducted at the first standing committee meeting.

Financial Considerations

The development of the attached proposed process is within scope of the day-to-day operations of the Clerk's Office.

Analysis

The Region's Procedural By-law (section 24.6) sets out that the principal business of the Council meeting held after the Inaugural Meeting is to establish the size of each Standing Committee, appoint Councillors to the standing and advisory committees, and appoint Acting Chairs and Co-Chairs for the standing committees.

With respect to appointing Councillors to the standing and advisory committees, the Bylaw states that if the number of Councillors wishing to serve on any standing or advisory committee, including agencies, boards and commissions, is greater than the number of positions available, then the selection shall be conducted by open ballot.

The By-law does not prescribe in detail the process for selecting representatives, nor does Niagara Region have a formal policy and related procedure for political and citizen appointments.

Staff is proposing a process, described in Appendix I, for Council's consideration. The recommended process proposes members need only receive the highest number of votes, eliminating the need to conduct numerous, time-consuming, rounds of open ballot voting. No longer would Councillors need to achieve support from the majority of members present at the meeting.

Given the short time frame until the first Standing Committees are held, staff are suggesting that the Regional Chair be allowed to act as a Standing Committee Chair should the need arise for a meeting to be called prior to January. This was undertaken as a consideration of the Procedural By-law Review Committee; however, no formal action was adopted with respect to this item.

Alternatives Reviewed

For the 2010 term of Council, the appointment process used required members to receive a majority vote, similar to the process used to select the Regional Chair; however, this was criticized for being awkward and time-consuming. Staff do not recommend using this process.

The other available alternative is to conduct the process in the same manner in which the Regional Chair is selected; whereby appointees would require a majority of the votes to be appointed to the various committees.

Relationship to Council Strategic Priorities

This report is in alignment with Council's strategic priorities of doing business differently and advancing organizational excellence.

APPENDIX I

COMMITTEES, AGENCIES, BOARDS AND COMMISSIONS APPOINTMENT PROCESS

The Region's Procedural By-law does not prescribe in detail the process for selecting Regional representatives to committees, agencies, boards and commissions.

Representation Requirements:

Standing Committee – The Procedural By-law section 24.6 (a) provides that Council establishes the size of each Standing Committee of Council.

Advisory Committee – Each advisory committee's Terms of Reference set out membership requirements. Amendments to Terms of Reference to reflect increased representation from members of Regional Council may be made in consultation with the advisory committee.

Agencies, Boards and Commissions – Each agency, board and commission sets and submits to Niagara Region the number of seats available for Regional representation.

Appointment Process:

The following is recommended as the appointment process for committees, agency, boards and commissions:

- Members are to select their preferred candidate via open ballot, as required.
- Where only one position is available, the candidate with the highest number of votes secures the position.
- Where more than one position is available, Councillors may select representatives up to the maximum number of positions available.
- Based on the results of the vote, the candidates will be listed in the order of highest number of votes to the lowest number of votes.
- Without further voting, positions will be awarded starting with the candidate who
 received the highest number of votes, then the second highest number of votes,
 third highest number of votes, etc., until all positions are filled.
- A tie in votes is decided by the Regional Chair, as required, and as provided for in section 4.6 of the Procedural By-law.

If a committee, agency, board or commission requires one Regional representative, and there are more candidates than positions available, members print the name of their preferred candidate on the ballot and sign their name. The candidate with the highest number of votes secures the position on the committee, agency, board or commission.

For a committee, agency, board or commission where Regional representation is greater than one, each Councillor shall have the option to cast a vote for up to the number of seats to be elected. After all the votes are cast, the seats will be filled by the Councillors who received the most votes.

For example, the Culture Committee requires six (6) representatives; therefore, each Councillor has the opportunity to vote for up to (6) six members of Council to serve as representatives. The six (6) Councillors that receive the highest number of votes will fill the available positions.

An open ballot shall include the name and signature of the Councillor casting the vote, and the name(s) of the Councillor(s) supported for the available position(s).

The names of the Councillors who voted in support of specific representatives will be recorded in the minutes.

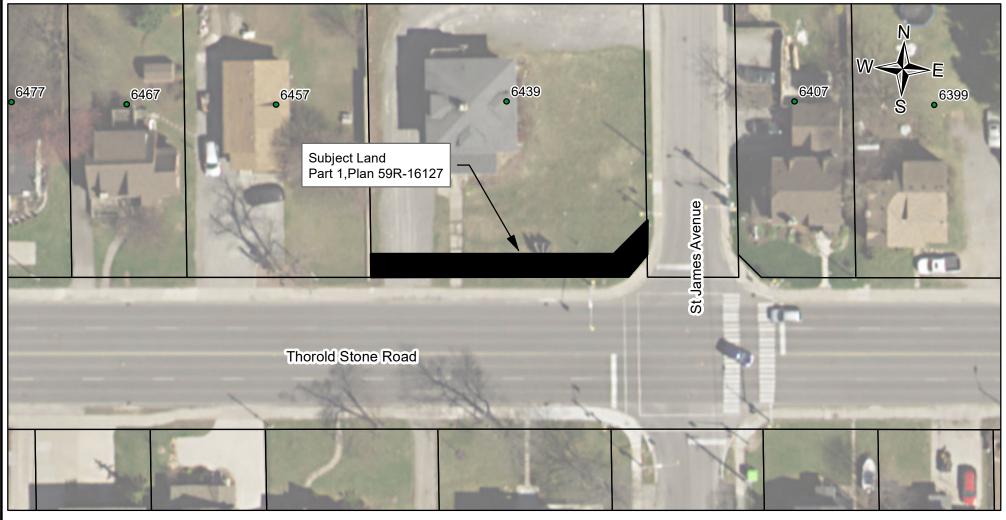

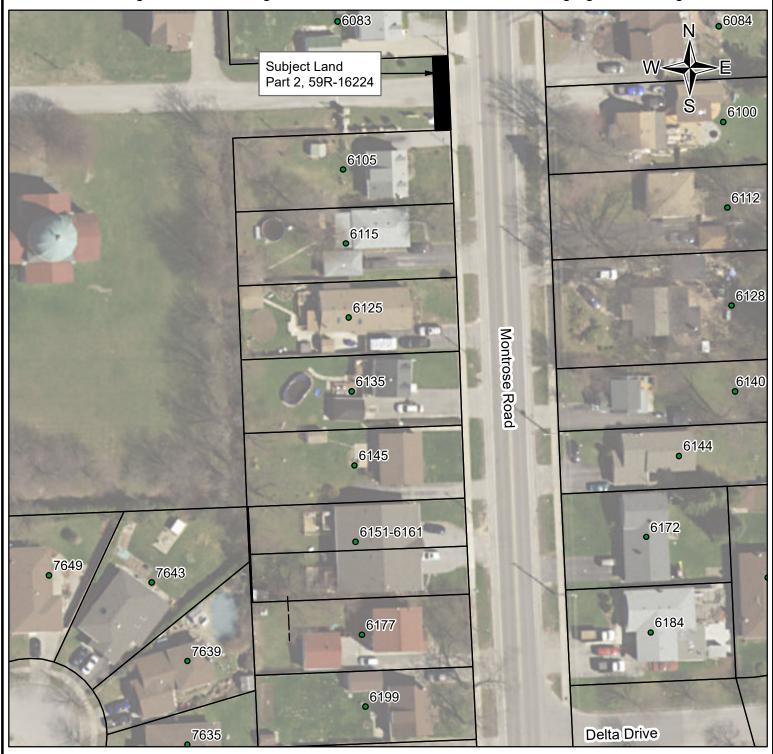

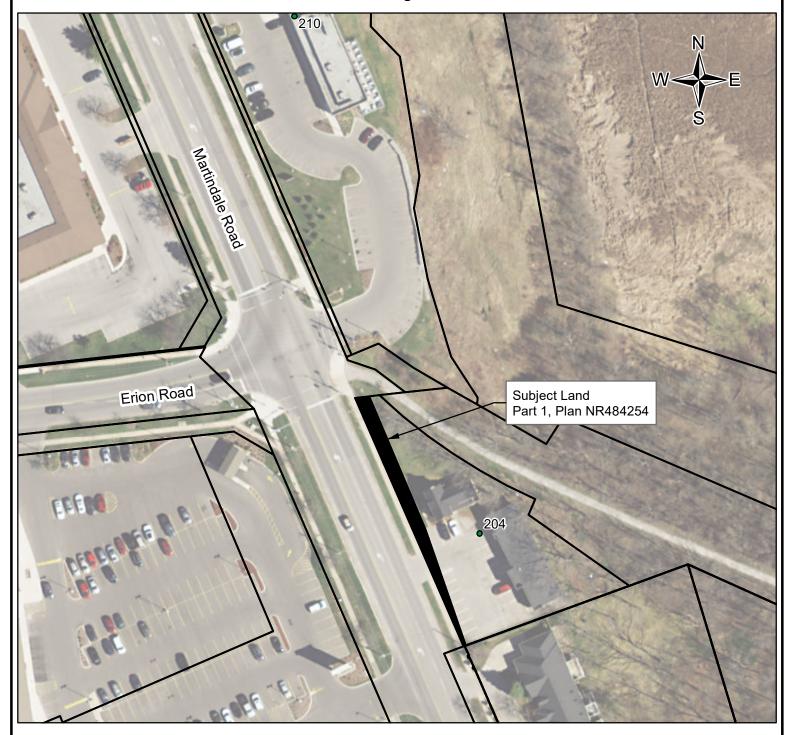

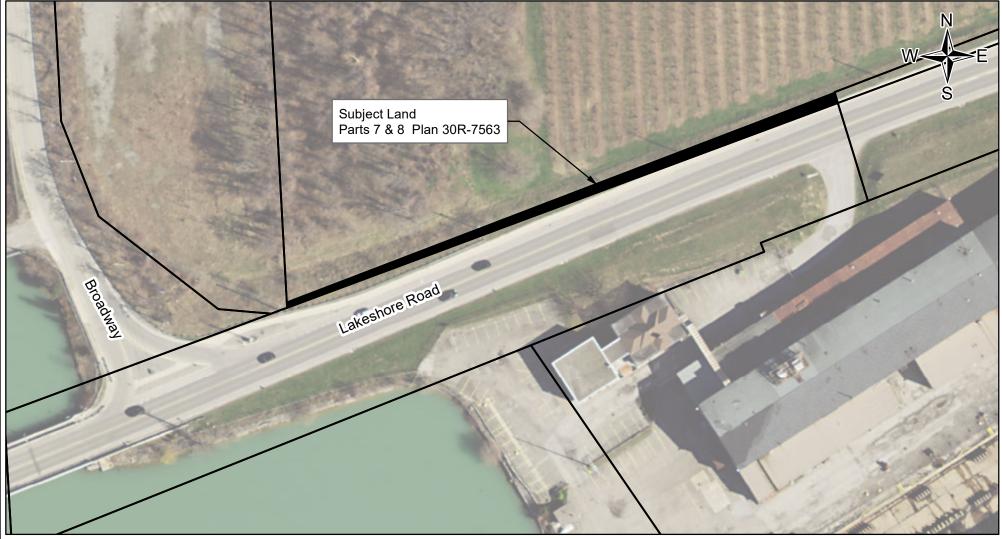

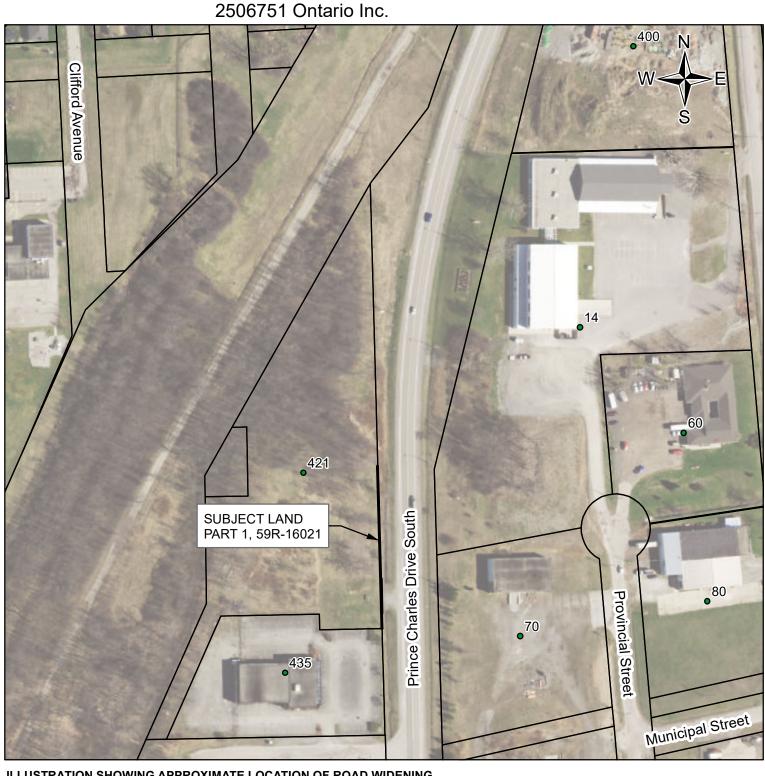

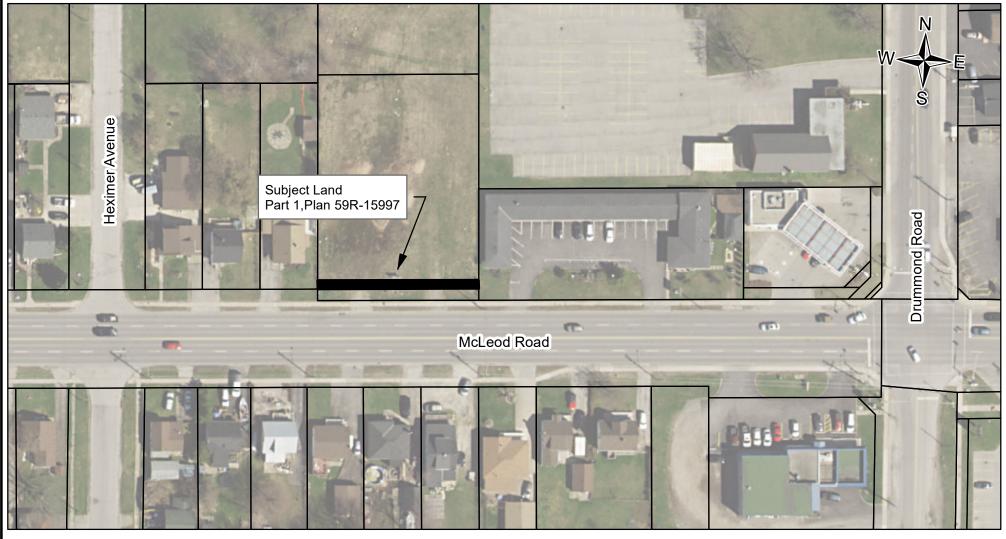

A BY-LAW TO ADOPT, RATIFY AND CONFIRM THE ACTIONS OF REGIONAL COUNCIL AT ITS MEETING HELD DECEMBER 13, 2018

WHEREAS subsection 5 (3) of the Municipal Act, S.O. 2001, Ch. 25, as amended, provides that, except if otherwise authorized, the powers of Regional Council shall be exercised by by-law; and,

WHEREAS it is deemed desirable and expedient that the actions of Regional Council as herein set forth be adopted, ratified and confirmed by by-law.

NOW THEREFORE the Council of The Regional Municipality of Niagara enacts as follows:

- 1. That the actions of the Regional Council at its meeting held December 13, 2018, including all resolutions or motions approved, are hereby adopted, ratified and confirmed as if they were expressly embodied in this by-law.
- 2. That the above-mentioned actions shall not include:
 - a) Any actions required by law to be taken by resolution; or
 - b) Any actions for which prior Ontario Municipal Board approval is required, until such approval is obtained.
- 3. That the Chair and proper officials of The Regional Municipality of Niagara are hereby authorized and directed to do all things necessary to give effect to the above-mentioned actions and to obtain approvals where required.
- 4. That unless otherwise provided, the Chair and Clerk are hereby authorized and directed to execute and the Clerk to affix the seal of The Regional Municipality of Niagara to all documents necessary to give effect to the above-mentioned actions.
- 5. That this by-law shall come into force and effect on the day upon which it is passed.
