8.2 Section 22 Order and COVID-19 Enforcement

1. That Regional Council **RECOMMEND** that the Acting Medical Officer of Health amend the directive under Section 22 of the Health Protection and Promotion Act with respect to who can be seated at a table at a restaurant and to remove the requirement limited to household members only;
2. That Section 22 **BE REVIEWED** every two weeks, with notification of proposed changes to be made to the Board of Public Health of Niagara Region, before being released publicly and that compliance with the Provincial framework be made a priority;
3. That the Acting Medical Officer of Health **IMMEDIATELY** enact a plan with the area Chief Administrative Officers and the Niagara Regional Police regarding strict enforcement of COVID-19 related by-laws and public health regulations to flatten the curve;

4. That Public Health **WORK** with area Chief Administrative Officers to immediately target those demographics that are causing the increase of COVID-19 with an aggressive communication campaign; and
5. That any fines issued related to COVID-19 related by-laws and public health regulations by the Niagara Regional Police, Public Health and municipal by-law officials **BE PUBLISHED** publicly.
