### Safety

- Swing gates
  - Cross 2/3 of the trail
  - They leave minimal space for passing
  - They are dark in colour
  - Collisions and injuries have occurred due to cyclists hitting gates



### Safety cont'd

### Posts

- In the middle of the trail
- Several different types (round/cement, wooden/square), with no visible markings
- Difficult to see, especially when cyclist are wearing eye protection



### Safety cont'd (2)

### Hazard

- Port Colborne bridge near the flour mill
  - Has two different types of barriers
  - Major dip at the end of the bridge
- Between St. Catharines and Port Colborne
  - No standardization of barrier types
  - Concern with rationale that barriers are to keep motorized vehicles off the trail
  - Suggestion of law enforcement to deal with motorized vehicles operators

### Maintenance

- Washouts; parts of the trail have disappeared
- City works cut grass and leave clippings on the trail
- Constant concern with ATVs throwing gravel on the trail
- Numerous cracks in the trail surface between Lock 1 and Homer Bridge



### Maintenance cont'd

- Pavement has heaved from frost in Thorold near E.S. Fox
- Potholes throughout the trail
- 5 ft pipe exposed where post was removed



### Wayfinding & Tourism

- Signage is required. Tourists express difficulty navigating many sections of the trail.
- Directions to attractions such as restaurants, cycling shops and shopping would be helpful.



### Wayfinding & Tourism cont'd

- Tourist experience is diminished by sections covered in debris
- Trail appears to end in downtown Welland with no indication of how to continue
- Transition to the Friendship Trail in Port Colborne is problematic



### Wayfinding & Tourism cont'd

- Lack of direction is problematic when emergency medical services are needed
- Tourists are not able to identify what municipality they are in due to lack of signage
- Colour coding trail/markings to differentiate municipalities

### Accessibility

- Barriers prevent access for persons using mobility scooters, handpowered, tandem bicycles and tricycles
- Barriers limit many older adults and individuals with mobility issues from using the trail
- Parents pushing strollers experience the same difficulties

### Recommendations

That the Transportation Steering Committee **RECOMMENDS** to the Public Works Committee:

- 1. That an extension of the Welland Canal Parkway Trail north of Lakeshore Road **BE APPROVED**:
- 2. That wayfinding initiatives on the Greater Niagara Circle Route **BE APPROVED**, and
- 3. That the necessary budget amendments to undertake these initiatives **BE CONSIDERED**.

### **Key Facts**

- The purpose of this report is to address two (2) notices of motion made by the Greater Niagara Circle Route Sub-Committee to utilize \$250,000 of the GNCR Reserve funds for: the extension of the Welland Canal Parkway Trail north of Lakeshore Road; and, a wayfinding initiative to propose a consistent strategy for trail signage.
- The grant amount of \$200,000 to the City of St. Catharines for the extension of the Welland Canal Parkway Trail north of Lakeshore Road, is for construction-related costs associated with a stone path extension and two (2) terminal lookouts over the canal.
- The \$50,000 for the wayfinding initiative is to procure a consultant assignment, facilitated by Niagara Region's transportation department, that will review the current entire trail wayfinding and destination routing and propose a consistent navigation strategy.
- These proposed initiatives were not included in the Council approved Niagara Region 2021 capital or operating budgets.
- Any in-year use of reserves not included in the Council approved budget must comply with the Reserve and Reserve Funds Policy (Corporate Policy C-F-013) as

well as the Budget Control By-law, and are considered a budget amendment which requires 10 days' notice prior to council approval as per Public Notice Policy (corporate policy C-RC-005). There is no impact on the tax levy as a result of utilizing reserves to fund these initiatives.

 Staff will be seeking direction from this committee at a future meeting on criteria for the use of the unrestricted balance of GNCR Reserve for specified purposes while following the Regional budget process each year.

### **Financial Considerations**

The GNCR Reserve current balance is \$1,382,681. It was funded from prior year surpluses and a \$10,760 donation restricted for use on the GNCR.

Staff is recommending a one-time amendment to the previously adopted 2021 Niagara Region Operating Budget in the amount of \$250,000. This consists of a grant of \$200,000 to the City of St. Catharines for the extension of the Welland Canal Parkway trail north of Lakeshore Road and \$50,000 for a consulting assignment to review the current wayfinding and destination routing throughout the entire trail. The initiatives are proposed to be funded from the GNCR Reserve. It is recommended that the restricted portion of \$10,760 (related to donations for the GNCR) in addition to a portion of the unrestricted portion be used to fund these requests. Any unspent amounts for the above noted initiatives will be returned to the GNCR reserve.

Any in-year use of reserves not included in the Council approved budget must comply with the Reserve and Reserve Funds Policy and the Budget Control By-Law. An in year use of unbudgeted reserves is considered a budget amendment which requires 10 days' notice prior to Regional Council approval as per Public Notice Policy (corporate policy C-RC-005). With endorsement of the recommendations included in this report by the Transportation Steering Committee and subsequently Public Works Committee, a report will be brought forth to Regional Council on May 20, 2021 seeking approval of the budget amendment in accordance with policy. There is no impact on the tax levy as a result of the utilization of reserves to fund these initiatives.

### **Analysis**

 The extension of the Welland Canal Parkway Trail north of Lakeshore Road is directed towards creating a safe and convenient trail extension within the City of St. Catharines to be used by Niagara Region residents and tourists. \_\_\_\_\_

- This project will address current operational and geometric deficiencies; while
  offering active transportation connectivity to the northern part of this trail along the
  Welland Canal.
- This project will be led by the City of St. Catharines in collaboration with the Transportation Services Division at the Niagara Region.
- There continues to be an increase in all forms of active transportation. This trail
  extension adds to the appeal of Niagara Region and the Circle Route being a cycling
  destination.
- Staff will prepare the necessary agreements as required, including with the City of St. Catharines, in a form satisfactory to the Director of Legal & Court Services. The grant will be provided to the City of St. Catharines upon confirmation of the extension costs. If the cost of construction is less than \$200,000, the excess budget will be returned to the GNCR Reserve.
- Staff will procure a consultant assignment that will review the current wayfinding and destination routing throughout the entire trail. A consistent navigation strategy will be proposed using signage and architectural landmarks. The proposed strategy will be reviewed with the Greater Niagara Circle Route Sub-Committee.
- Following completion of the wayfinding consulting assignment, any
  recommendations for enhancements and/or improvements to the trail will be
  discussed with Transportation Steering Committee (TSC). Any cost implications
  associated with these recommendations will be considered as part of future budget
  processes.
- Property ownership, maintenance and operations fall under the jurisdiction of respective local area municipalities; not that of the Region. As part of the GNCR workplan, roles and responsibilities of the Region and local area municipalities will be identified and brought forward to TSC for consideration and approval.
- Staff will be seeking direction from TSC in Q3 2021 on parameters for future utilization of the GNCR Reserve for active transportation projects in alignment with the annual budget process.

#### **Alternatives Reviewed**

The decision to fund a grant to the City of St. Catharines and wayfinding consulting utilizing the GNCR Reserve could be deferred and considered during the 2022 Regional Budget Process in alignment with normal practice.

**Subject: 2021 Bicycle Facilities Grant – Regional Bikeways Network** 

**Facilities on Municipal Roadways**

Council approved \$200,000 for the 2021 Bicycle Facilities Grant Program, through Transportation's Planning Business Unit. This year's program was extremely well-received with six (6) applications submitted from seven (7) municipalities and funding requests totalling well over one (1) million dollars.

The recipients of this funding are:

Town of Pelham - \$30,000 - This funding is to be directed to the re-construction and urbanization of Pelham Street between Port Robinson Road and John Street. In addition to new driving lanes and concrete sidewalks, the project will feature new onroad dedicated bicycle lanes and a multi-use path in front of Glynn A. Green Public School.

Town of Lincoln - \$50,000 – This funding is to be directed to the construction of a multi-use path (MUP); connecting St. John Elementary School to the existing sidewalk network on the south side of RR81 (King Street) in Grimsby. The project is a joint effort between the Town of Grimsby and the Town of Lincoln, with sidewalks being constructed in both municipalities.

City of Welland - \$50,000 – This funding is to be used for the upgrade to the 1.6 km length of multi-use trail; directly adjacent to local road Clare Avenue. The stretch runs alongside Clare Avenue from Woodlawn to the Pelham/Welland boundary near Quaker Road and is the only pedestrian connection along this road section.

City of Niagara Falls - \$70,000 – This funding is to be directed to the Connects Millennium Trail to Niagara Parkway Recreation Trail; to construct a multi-use path (MUP) along Drummond Road and Morrison Street. This Active Transportation network

is proposed to connect at the north end of the existing Niagara Parkway Recreation Trail.

This grant program is in support of Niagara Region's initiative for increased active transportation via on-road bicycle facilities and MUPs; constructed as part of roadway rehabilitation or reconstruction projects. To help facilitate the Municipal segments of Niagara Region's Bikeways Network, this Grant will be provided as per *Policy 9.F.3 of the Regional Policy Plan. Niagara Region's Transportation Master Plan,* 2017 provides details regarding which municipally owned and operated roadways are included within this program and the type of proposed bicycle facility that has been identified.

The expectation is that the Grant funding, once awarded, will be used for design and construction during the annual award year. However, Niagara Region recognizes that these are extraordinary times due to the pandemic, and that some of the awarded projects may not be able to proceed as anticipated for a variety of reasons. If this becomes the case, and the above-noted project is not able to proceed as intended, written notification shall be provided to the Region by October 1, 2021, to allow the Region the opportunity to redirect the funding towards other projects within this fiscal calendar year. Staff look forward to being kept apprised of project status and progress throughout the project.

#### 3) GNCR Tourism Collateral – L. Sicoli, Economic Development

- Overview on how Economic Development can engage in Circle Route goals and visibility to the route
- T. Ugulini: Have you reached out to Sue Morin? She is a good resource.
- L. Sicoli: Yes. I have spoken to S. Morin and she provided good context and background
- T. Ugulini: Niagara Freewheelers made a presentation at our last meeting and they would also be a great resource.
- C. Ryall: We have been closely linked with S. Morin and been in conversations about updating the cycling map. It is one of the larger initiatives of ATSC.
- B. Greenwood: I had many great comments on the current map. It's an age of transition, so paper is still necessary.
- L. Sicoli: We can provide some marketing support from our end as well. If you
  want something specific, we can connect with social media promotion. If you
  identify social media influencers, we can connect them to our marketing department
  to move forward.
- T. Ugulini: We need to maintain the link with Economic Development and put our best foot forward promoting the GNCR. We need to make sure we get the word out and maintain it.
- L. Sicoli: We are happy to support the membership to Ontario By-Bike Association. It is about to expire. It is a "go-to" membership for cyclists.
- N. Dubanow: Made a motion 2<sup>nd</sup> by D. Dodge
  - To renew our Ontario By-Bike Association membership, to be paid for by Economic Development. Carried – Will go to TSC then to PW.
- C. Ryall: Once approved we will work with Economic Development to move it forward.
- L. Sicoli: I would like to stay as a connected thread to the GNCRC to better understand how Economic Development can assist.
- C. Ryall: ATSC's renewal of the cycling map is a major initiative. We use it in

different forums, showcasing our infrastructure. We are working with S. Morin and the LAMs, looking to get bike infrastructure to include on map update. The intent of the map is strictly around cycling. S. Morin and I are working to complete this by the end of April timeframe.

B. Greenwood: The timing is great getting this out in time for the good weather.

### 4) Greater Niagara Circle Route Update

i) The reporting structure for the Greater Niagara Circle Route Committee was transferred from Planning and Economic Development Committee to Public Works Committee – PDS 36-2020 Approved at PEDC December 9, 2020.

#### 5) GNCR Work Plan Review

- To be submitted to TSC April 27, 2021 for approval, then next steps will be implemented.
- T. Ugulini: R. Dillon met with our Public Works Department and they are implementing improvements.
- N. Dubanow: R. Dillon also met with our staff. She is an excellent resource.
- C. Ryall: In support of what we're doing in GNCRC, we are having her attend TSC and do a condensed version of her presentation.
- B. Greenwood: I think it would be great to pass along the information to the proper committees.
- N. Dubanow: I agree to bring her to TSC to give a broad overview of the Circle Route
- B. Greenwood: Communication among committees and people is vital.
- C. Ryall: Having R. Dillon come forward to outline the current state of the Circle Route, may help with additional funding or other opportunities which may really help us.
- B. Greenwood: Bringing the existing map to TSC to hand out would be helpful. It's a great promoter of the Niagara Region.
- C. Ryall: We will take this away as an action item to reach out to Rita to present a 15 minute overview at TSC.
- T. Ugulini: I absolutely agree.

#### **Wayfinding**

- T. Ugulini: Is there a way we can do joint funding between the municipalities and the Region, using resource dollars so the signage is consistent? Does it have merit to work as a partnership and everyone has buy in?
- C Ryall: We can bring a motion forward that talks to a shared financial contribution between the Region and the municipalities. The region could hire a consultant to do a wayfinding strategy specifically for the Circle Route.
- N. Dubanow: Fort Erie already has a program for wayfinding underway. We did
  this at the municipal level. It was approved in 2010 and was implemented in
  2019.
- T. Ugulini: I think Welland's is also well underway.
- F. Greenwood: Could we have a look at what Fort Erie and Welland has in progress?
- N. Dubanow: We have reports with a specifically designed framework. They are
  publically available on the website as to how we are moving forward. I am
  concerned that our signs won't meet the Regional specs for signage. Is there a
  way we can make it work?
- C. Ryall: The Region put forward a general wayfinding program consistent across
  the Regional right of way across all municipalities. It wasn't approved a number
  of years ago. The LAMs have been progressing with their own wayfinding.

Anything on Regional roads has been in consult with the Region. Perhaps we can reach out to the different operations groups at the LAMs that touch the Circle Route and see if they have any strategies they would like to bring forward. I feel it is still best to bring a consultant in to review this. There are many options to use in way finding. Having a consultant as part of the committee is valuable.

- T. Ugulini: In the short term, we should reach out to the municipalities to see where they are at in terms of signage and report back to this group. Then we can make a decision.
- C. Ryall: Yes. We should try to get this done in the next week and be mindful of the timing of next the TSC.
- T. Ugulini: We can host a short meeting on this wayfinding item only. Then make a decision prior to the March TSC.
- C. Ryall: We will reach out to the LAMs for this information and call another meeting.

### **Future Network Expansion:**

- PEDEC wanted to make the completion of the Circle Route in north St. Catharines, a priority in their 2021 work plan.
- D. Dodge: Do we want to put a motion forward to start this work?
- T. Ugulini: The workplan is not in order of priority. We should use bullet points instead of numbers.
  - Dodge made a Motion, 2<sup>nd</sup> by Campbell Carried
- B. Greenwood: How much money has been invested in the Circle Route over the last couple years?
- T. Ugulini: My understanding is there has been no money spent recently. Any work that has been done, has been paid for by the municipalities (i.e. asphalt repairs).
- C. Ryall: Prior to the group going into abeyance, there was a dedicated pot of dollars. There has been no recent activity for money to be put into. I reached out to Finance to confirm what is available. I would need to go to TSC for a budget adjustment to use those dollars. This wasn't approved through the Capital budget to use those dollars.
- B. Greenwood: This would open it up for new people to understand the ongoing work in the municipalities. It would be a good message to give to the whole council.
- C. Ryall to come back with actual numbers of the money available.
- C. Ryall: I reached out to St. Catharines. There is a design completed and on hold, pending a decision with the Region for \$80k – 90k to do the work. I will brief T. Ugulini prior to TSC meeting in March.
