History:

Procedural By-law Review Committee established in 2015:

- Reviewed by-law themes
- Final draft provided to Committee in 2018 but never approved to move forward for Council consideration



Recent Work:

2019: Updates made due to legislative changes and Ombudsman Reports "Press Pause" and "Inside Job"

2020 and 2021: Amendments for Electronic meetings

2022: New Code of Conduct added



Recent Work:

The Committee approved a number of amendments for Council's consideration in September 2022 including:

- Definitions
- Changes to when materials are due to be published on an agenda
- Delegations (speaking time, requirements for speaking notes, when not appropriate, decorum)

Key Facts

- Subsection 238 (2) of *The Municipal Act, 2001*, provides that every municipality and local board shall pass a procedure by-law for governing the calling, place and proceedings of meetings.
- There is little prescription in Section 238.
- Regional Council's Procedural By-law was enacted in 2010 and is composed of over 60 pages including the Code of Conduct. It has been amended 26 times.
- The Committee goal was to review the Procedural By-law to develop simplified and streamlined processes and procedures, enhance meeting efficiency, and ensure access and transparency.

Committee Goals

1. Revised/New By-law which would include:

simplified provisions, plain language, reduced prescription, reflect legislative requirements, and support access, accountability and transparency of the Council decision making process.

clear, simplified processes with documented rationale, and procedures
