
# **Enquiry from Region website**

There are some excellent reasons for this: 1) There seems to be a misconception about the role of masks. Wearing a mask protects others from being infected. So, if an individual is a silent carrier, super spreader, or if he has symptoms, a mask will help prevent him from infecting others. We need to wear masks to protect others. In turn, we are then less likely as a community to experience a high rate of infection if everyone is wearing a mask (and we practice social distancing as well as frequent hand-washing). 2) school is now in session, so more large gatherings will facilitate the spread of Covid-19. With greater numbers of Covid infections, the more necessary the mask mandate, to prevent an untenable situation for health care workers. 3) We are heading into flu season, which means society will be more vulnerable to illness from a least 2 deadly viruses. Not only are there more gatherings occurring, they will be happening indoors as the temperature drops, increasing the rate of spread. So, masks will be necessary to contain the spread. Regional Chair Bradley and Members of Regional Council: I am writing to you today in support of extending Niagara Region's face covering by-law. As a resident of the Town of Lincoln, and a lifelong resident of Niagara Region, it is my duty as a citizen to ensure my voice is heard on what has been the most severe public health crisis to face our community in our lifetimes. The world's understanding of COVID-19 has changed dramatically since the first days of the pandemic. In those early days, the efficacy of wearing anything other than an N95 respirator was doubtful. However, with time and study, the world's understanding of the virus has changed. There is, without question, much that we still do not understand about this virus and how it impacts human health. However, the best scientific minds in the world have shown that there is a demonstrable reduction in the transmission of the virus if face coverings are worn, physical distancing observed, and hand hygiene improved. There are numerous peer reviewed scientific journals which support these facts - The Lancet, the Journal of American Thoracic Society, the Canadian Thoracic Society, The New England Journal of Medicine, The BMJ, etc. Although Niagara's COVID-19 numbers have been low, this is not the time to relax our vigilance. Niagara's low numbers demonstrate that the wearing of face coverings, the observance of physical distancing, and improved hand hygiene work! We have seen over the past two weeks that Ontario's case numbers could be on the rise again. This could be the early signs of a second wave such as what has been seen elsewhere in the world. We need to remain on quard against this virus. We cannot afford to relax. We need our economy to be reopened for the good of us all, and wearing face coverings is a way to make this happen without needlessly putting lives at risk. Niagara Region's own public health experts have said, time and again on this matter, that face coverings work. There are those that will say Niagara's low numbers demonstrate we never needed face coverings and that COVID-19 is not a threat. This is sheer and utter nonsense and reflects a willful ignorance that puts all of us, especially the most vulnerable members of our community, at risk. It is akin to saying that a reduction in automobile crash fatalities are proof that seatbelts should not be required. There are those who say that mandating a face covering is against the Charter of Rights and Freedoms or in violation of some sense of personal liberty. That our great Constitution would be used as a tool for such selfish ends is disappointing. I cannot imagine our parents and grandparents balking at mandatory blackouts during wartime to prevent our cities from being destroyed because of some ill-conceived notion of rights as we have seen with some of the submissions made to Regional Council on this

matter. I urge Regional Council to weigh the scientific facts of this matter carefully, and to discard the falsehoods that have been peddled by opponents to this by-law. Mandatory Requirement for Masks Public Spaces - COVID-19 I wanted to share my views on the continuation of using masks/face coverings to reduce the spread of COVID-19 in the Niagara Region. As an occupational hygienist for more than 30 years I feel I can speak to this issue. Any occupational hygienist and public health official understands that in order to protect individuals one must implement a control methodology that is based on a hierarchy of controls which ranges from engineering controls (ventilation, isolation), administrative controls (limiting numbers in public spaces, physical distancing) to personal protective equipment (use of masks); providing layers of protection. In occupational settings the Occupational Health and Safety Act requires that employers take all reasonable precautions to protect their employees, and hence the requirement for employees to follow all prescribed requirements (hierarchy of controls) as established by the employer (ex. first line workers). For the general public, this philosophy of applying the hierarchy of controls needs to be the same; understanding that not all controls can be implemented such as ventilation (engineering control). This leaves us with isolation, physical distancing and masks as the alternatives for protection.

which rely on individuals adhering to these requirements. As we have seen, human behaviour and adherence to these requirements varies greatly and more specifically non-adherence has resulted in increased rates of infection. The elimination of the need to wear masks or facial coverings eliminates a fundamental control and layer of protection in our efforts to protect individuals and those most at risk. We do need to respect those individuals that have a bonafide medical reason not to wear a mask, but as a society we must look at the greater good, the protection of all individuals. Wearing a mask to protect myself and others in public spaces is not an imposition to protect a life.
