#### 1. **CALL TO ORDER**

The amendment consists of mapping changes to re-designate the Northwest Welland study area to urban area and add a site specific policy area to recognize the expansion area.

The Committee Vice-Chair stated that any person present on the video conference, or by phone, who wished to make representation on the proposed amendment would be given an opportunity to do so. He additionally advised that written submissions may be placed on a public agenda and become part of the public record. Personal information will be collected and maintained for the purpose of creating a record and may be available to the general public pursuant to the *Municipal Act*, the *Municipal Freedom of Information and Privacy Act*, and any other relevant Acts. Any questions related to the privacy policy, should be directed to the Regional Clerk's Office.
