## 7. OTHER BUSINESS

## 7.1 Replacement of Damaged Recycling Bins

Councillor Foster raised concern with the decision to eliminate the funding for replacement recycling bins that was made as part of the 2021 budget deliberations. Catherine Habermebl, Director, Waste Management Services, advised that the annual cost of this service is approximately \$111,000.00. Councillor Foster advised that in light of the new waste management collection contract it would be reasonable to continue to fund replacement recycling bins and that he would consider bringing this forward for further discussion.

#### 7.2 Town of Lincoln Resolution – Options for Securing Recycling Bin Contents

Councillor Foster advised Committee members of a motion passed by the Town of Lincoln respecting options to secure recycling bin contents. Catherine Habermebl, Director, Waste Management Services, advised staff were in receipt of the motion and that a report was provided to the Waste Management Planning Steering Committee regarding a completed blue box lid trial. She advised that a report would be brought to the Public Works Committee meeting being held on April 13, 2021, regarding this matter.

# 7.3 <u>Environmental Assessment of Regional Road 14 (Bartlett Avenue), Town of Grimsby</u>

Councillor Witteveen requested an update respecting the environmental assessment of the proposed Regional Road 14 (Bartlett Avenue) northbound and southbound extension into the Township of West Lincoln from the Town of Grimsby. Carolyn Ryall, Director, Transportation Services, advised that staff are currently drafting the terms of reference for the environmental assessment in consultation with the Ministry of Environment, Conservation, and Parks. She noted that an update on the project would be provided to the Committee at an upcoming meeting.

# 7.4 <u>Wastewater Lagoons - Township of West Lincoln</u>

Councillor Witteveen enquired about the process to decommission the wastewater lagoons located in Smithville and to change the property to a naturalization site. Bruce Zvaniga, Interim Commissioner, Public Works, advised that staff would provide additional information regarding the process to the Councillor.

# 7.5 Great Lakes Watershed Cleanup

Councillor Fertich advised that various Rotary Clubs in Niagara Region, throughout Canada and the United States would be participating in the Great Lakes Watershed Cleanup from April 17 to April 24, 2021, which coincides with Earth Day on April 22, 2021.
