BY-LAW NO. 389-2021

A BY-LAW TO PROVIDE FOR THE IMPOSITION OF CHARGES FOR POLICE SERVICES

(as amended by By-laws 268-2004, 278-2006, 280-2006, 287-2009, 288-2009, 296-2010, 302-2010, 303-2010, 304-2010, 308-2011, 329-2012, 347-2014, 353-2014, 359-2016, 371-2017 and 388-2020)

1. **PREAMBLE** 1.1 WHEREAS the Regional Municipality of Niagara Police Services Board is responsible for the provision of police services and for law enforcement and crime prevention in the Regional Municipality: 1.2 AND whereas the Board has determined that it is appropriate to charge user fees in respect of certain service provided to any person; 1.3 AND whereas section 391 of the Municipal Act, 2001, S.O., c.25, and amendments thereto, provides that a local board may pass by-laws imposing fees or charges on any class of persons for, inter alia, services or activities provided or done by or on behalf of it. 1.4 AND whereas section 396(1)(b) of the Municipal Act, 2001, S.O., c.25, and amendments thereto, provides that discounts and other benefits for early payment of fees and charges may be given; 1.5 AND whereas section 396(1)(c) of the Municipal Act, 2001, S.O., c.25, and amendments thereto, provides that variable fees are considered appropriate by the Board may be charged in respect of such services; 1.6 AND whereas the said section 397 of the Municipal Act, 2001, S.O., c.25, and amendments thereto, requires that the Regional Municipality must pass a resolution approving the said by-law before it comes into force.

NOW THEREFORE THE REGIONAL MUNICIPALITY OF NIAGARA POLICE SERVICES BOARD ENACTS AS FOLLOWS:

2 DEFINITIONS

- 2.1 "Board" means the Regional Municipality of Niagara Police Services Board;
- 2.2 "Person" means any member of the public and includes an individual, sole proprietorship, partnership, corporation, any other police service, and any other government body or agency;
- 2.3 "Police Service" means the Niagara Regional Police Service;

- 2.4 "Member" means a member of the Niagara Regional Police Service;
- 2.5 "Regional Municipality" means the Regional Municipality of Niagara.

3 CHARGES FOR SERVICE

- Any person requesting and receiving any service described in Schedule "A" to this by-law shall pay the fee for such service as set out in the said Schedule "A", plus HST if applicable.
- 3.2 Any person requesting and receiving any service described in Schedule "B" to this by-law shall pay a fee for such service in accordance with a written agreement made between the Police Service and such person, plus HST if applicable.
- Any person for whom the police service provides a service and in doing so incurs a cost not listed in Schedules "A" or "B" or in this by-law, shall pay to the police service an amount equal to the cost so incurred by the police service.

4 REPEAL OF FORMER BY-LAW

4.1 The provisions of By-law No. 371-2017 and other By-laws, sections of By-laws and user fees and charges of the Police Service inconsistent with the provisions of this By-law are hereby repealed and replaced by this by-law.

5 ENACTMENT

This By-law shall come into force upon the date that it is approved by Council of the Regional Municipality of Niagara.

Recommendation(s)

That the Police Services Board approve the revised rates and direct staff to ensure that all documentation be updated accordingly.

Key Facts

- The purpose of this report is to update the Schedule of Fees and Charges by making the recommended changes
- Creating fees for officer notes and witness statements in relation to motor vehicle collision reports
- Removal of False Alarm attendance fees

Financial Considerations

Requests for witness statements and officer's notes will be removed from the FOI process and reassigned to the Insurance Clerk. As such, the Service will be able to apply fees as the procedure falls outside the *Municipal Freedom of Information and Protection of Privacy Act*. On average, the Service receives approximately 212 requests per year. After considering provincial averages, the Service is recommending a fee of \$50.00 for each item. The recommended changes have a potential for generating \$31,800.00 per year.

It is further recommended that the fee for police attendance at False Alarms be removed from the schedule as the Service no longer applies false alarm fees.

Analysis

Managing the above noted requests outside of the formal Freedom of Information process allows the analysts to focus on the more complicated access to information requests. It also allows the service to apply appropriate fees. Of the 34 police services surveyed, 32 manage witness statements and officer's notes in the same manner as being proposed.

Alternatives Reviewed

There are currently no fees allocated to officer notes and witness statements.
