4. That Council **AUTHORIZE** either one of the Commissioner of Community Services or the Director of Housing Services/Chief Executive Officer Niagara Regional Housing to execute all documentation related to the New Development Housing Allowance Program; and
5. That Council **DIRECTS** staff to consider incorporation of the authority granted herein within the Schedule "A" (delegated authorities) of the next revision of By-law 09-2016, being a By-law to Govern Execution of Documents and Delegate Certain Administrative Powers and Duties to Staff.

Cathy Cousins, Director, Homelessness and Community Engagement, advised that a consortium proposal to the Ministry of Children, Community and Social Services, led by the YWCA Niagara Region has been approved. This proposal included safe beds for victims of human trafficking as well as elements pertaining to prevention and education.
