1. CALL TO ORDER

2. LAND ACKNOWLEDGMENT STATEMENT

Committee Chair Huson read out the Land Acknowledgment Statement:

This territory is covered by the Upper Canada Treaties, is within the lands protected by the "Dish with One Spoon" Wampum Agreement.

Today, this gathering place is home to many First Nations, Metis, and Inuit Peoples and acknowledging reminds us that our great standard of living in Niagara is directly related to the resources and friendship of the Indigenous people.

6. ITEMS FOR DISCUSSION

6.1 16 Days of Activism against Gender-Based Violence

Jean Tonogai, Member, Maureen Shantz, President, and Gail Neff, Past President, Canadian Federation of University Women (CFUW) St. Catharines, appeared before Committee regarding the 16 Days of Activism against Gender-Based Violence and to provide information respecting their organization. The CFUW is committed to the pursuit of knowledge, promotion of education and the improvement of the status of women and their human rights. The CFUW is supportive of the 16 Days of Activism against Gender-Based Violence campaign which is an annual international campaign that kicks off on 25 November, the International Day for the Elimination of Violence against Women, and runs until 10 December, Human Rights Day. It was started by activists at the inaugural Women's Global Leadership Institute in 1991 and continues to be coordinated each year by the Center for Women's Global Leadership. It is used as an organizing strategy by individuals and organizations around the world to call for the prevention and elimination of violence against women and girls. The CFUW expressed an interest in working with Niagara Region and the Women's Advisory Committee to increase awareness of the campaign.

6.2 Child Care Update

Ruth Unrau, Committee Vice Chair, provided an update respecting child care. Ruth advised that a meeting was held with groups interested in child care issues. Nine recommendations were brought forward and from those three priorities were identified in coordination with Niagara Region Community Services staff. The three priorities identified were:

- development of a recruitment and retention strategy for Registered Early Childhood Educators (RECEs)
- provincial allocations and capital expansion funds, at a minimum, should be maintained, and more capital and operating funds are needed to expand licensed child care, including both centre-based and licensed home child care and
- maintaining and enhancing child care fee subsidies is crucial to addressing affordability in child care
