7.2 Pedestrian Crosswalks and Road Safety

Councillor Zalepa requested information respecting how pedestrian crosswalk locations are selected and expressed concern with ongoing issues regarding excessive speed. Carolyn Ryall, Director, Transportation Services, advised that requests for pedestrian crosswalks are reviewed by staff and based on set criteria a decision is made regarding the type of crosswalk that should be implemented taking into consideration safety concerns. She noted that speed enforcement falls within the jurisdiction of the Niagara Regional Police Services and that staff work closely with them regarding the tracking of speeding trends at various locations throughout the Region.
