7. OTHER BUSINESS

7.1 Forks Road Bridge, City of Welland

Moved by Councillor Campion Seconded by Councillor Chiocchio

Whereas the Forks Road Bridge was downloaded to the City of Welland on May 1, 2000 by the Region of Niagara;

Whereas the Forks Road Bridge was a 70 year old structure when downloaded by the Region in 2000;

Whereas the Forks Road Bridge is the largest and most costly structure downloaded by the Region to any of the local area Municipalities during the region-wide downloading in 2000;

Whereas Regional Road Criteria published as of April 1997, around the time that Regional Road downloading was initiated, stated that Regional Roads should do one or more of the following:

- Connect Urban Centres
- Service Heavy Industry and Tourism
- Cross Barriers (such as the Welland Canal)
- Be an Urban Area Connecting Link;

Whereas Forks Road is a Regional Road in Wainfleet, only 1 km away from the Forks Road Bridge;

Whereas a petition has been received by Welland City Council on January 15, 2019 signed by 1,947 petitioners;

Whereas approximately forty percent of those signing the petition reside in the Region outside of Welland;

Whereas roads and bridges makeup the largest subset of the Regional capital budget, with spending in 2019 of approximately \$100M;

Whereas the proposed capital spending in Welland on Roads and Bridges in 2019 by the Region is \$3.9M, and has been minimal in the past several years; and,

Whereas the Forks Road Bridge is important to the continued Regional economic development and job creation.

NOW THEREFORE BE IT RESOLVED:

That the Region of Niagara **ASSUME** the Forks Road Bridge and budget \$4 million in the 2019 capital budget for demolition, pier testing and detailed design of Forks Road Bridge.

That the following motion **BE REFERRED** to staff to provide a report for the Budget Review Committee of the Whole meeting being held on February 14, 2019:
