Transfer of Road Jurisdiction - Regional Road 20 (Highway 20) and South Grimsby Road 10, Township of West Lincoln

That Report PW 27-2023, dated July 11, 2023, respecting Transfer of Road Jurisdiction-Regional Road 20 (Highway 20) and South Grimsby Road 10, Township of West Lincoln, **BE RECEIVED** and the following recommendations **BE APPROVED**:

- 1. That pursuant to its authority under subsection 52(4) of the *Municipal Act, 2001*, Regional Council **APPROVE** removing a portion of South Grimsby Road 10, more particularly described and designated as being Parts 10-14 on Reference Plan 30R-15936 (the "Download Lands") and having an area of approximately 3,791 square metres more or less and shown on Appendix 1 attached hereto, to be transferred to the Township of West Lincoln ("Township");
- 2. That pursuant to its authority under subsection 52(1) of the *Municipal Act*, 2001, Regional Council **APPROVE** adding the parcels of lower-tier portions of South Grimsby Road 10, more particularly described and designated as being Parts 1, 2 and 6 on Reference Plan 30R-15936 (the "Upload Lands") and having an area of approximately 794 square metres more or less and shown on Appendix 1 attached hereto, to be transferred to Niagara Region;
- That a copy of this report and a copy of Regional Council's decision BE CIRCULATED to the Township, as the Upload Lands will now be under the jurisdiction of Niagara Region;
- 4. That the necessary by-laws **BE PREPARED** and **PRESENTED** to Regional Council to add the Upload Lands to the Regional Road system and remove the Download Lands from the Regional Road system; and
- 5. Upon passage, a copy of the by-laws **BE CIRCULATED** to the Township, as the Upload Lands will be removed from the jurisdiction of the Township.

- 2. That staff **BE DIRECTED** to notify Circular Materials Ontario and advise Local Area Municipalities of Niagara Region's decision respecting the provision of curbside collection of Blue Box materials; and
- 3. That, as a service to residents and in the interest of waste diversion, staff **BE DIRECTED** to develop and implement a communication strategy leading up the transition date (January 1, 2024) to advise residents of the changes to the residential Blue Box program.

7. OTHER BUSINESS

7.1 Grass Clippings

Councillor Huson requested an explanation as to why grass clippings were no longer collected in the organics bin and what options residents had for disposal. Catherine Habermebl, Director, Waste Management Services, explained, due to odor issues impacting surrounding neighbours of the processing facilities, grass clippings are no longer collected and noted that residents have the option to recycle the clippings back onto the lawn or dropping them off at one of the waste depots without cost.

7.2 <u>Mewburn Road and Concession 6 Road, Niagara-on-the-Lake -</u> Construction Update

Councillor Gale requested information on the construction plans for Mewburn Road and Concession 6 Road including, who is responsible, projected timelines and the long-term plan for this area.

7.3 <u>Hauler Station Update</u>

Councillor Villella requested an update on the temperature concern in the hauler stations. Joe Tonellato, Director, Water & Wastewater Services, advised that they are currently working to address the temperature issue in the hauler stations.

Councillor Insinna requested clarification on the type of biodegradable bags that can be used in the organics bin. Catherine Habermebl, Director, Waste Management Services, advised that the Niagara Region website provides information on the proper types of disposal bags.
