This memorandum is intended to provide Committee members with an update on the outstanding Councillor Requests from previous meetings.

Waste Management Planning Steering Committee

Meeting Date: June 26, 2023

Minute Item #3.2: Councillor Rigby requested information regarding costs for a coffee pod recycling program or other options for coffee pod recycling at Niagara Regional Headquarters.

Follow-up Action: Nespresso is the only known free coffee capsule return program available, however they only accept their own brand of aluminum coffee pods for recycling in their program. Two other known programs are available, however at a cost. One through Keurig, which only accepts Keurig brand pods, and another one through Terracycle which accepts all brands of coffee pods, capsules, and discs.

Keen on Green, a multi-departmental staff-based committee, is currently promoting the Choose to Reuse campaign to increase awareness amongst Regional employees about the challenges of single use coffee cups and pods. This campaign encourages low waste coffee practices. It also includes the incentive to purchase coffee in the cafeteria at Regional HQ by offering a small discount when reusable mugs are used.

One proposed initiative, that is being considered, is a free drip coffee incentive program for staff with a reusable mug that can be combined with a ban on single use coffee machines at Regional HQ in Thorold. This could be piloted at the HQ building, and if successful, can be rolled out at all Regional Facilities with a large enough servery or cafeteria. This would provide a noticeable impact on the garbage stream, minimizing single use cups, lids, creamer/milkette containers, and coffee pods/capsules of all kinds. Based on the results of the waste audit at Regional HQ, an annual total of 43,250 coffee

cups was estimated to be generated in the 2022 calendar year, under hybrid working conditions, which represents a weight of 872.00 kg/yr or 9.8% of the garbage stream.
