Subject: Waste Management Strategic Plan Update

In order to plan for waste management needs over the 25-year period, Niagara Region is coordinating a series of research and consultation activities, designed to solicit input from key stakeholders, identify best practices from other jurisdictions, and generate the required data to support the resulting recommendations. To develop the Waste Management Strategic Plan (WMSP), Niagara Region is taking a three-phased approach:

- (i) Assessment of System (current phase)
- (ii) Development of Direction and Systems Options
- (iii) Preferred System

The Request for Proposal (RFP) for the WMSP, in its entirety, was previously released with no bids received. In order to simplify the overall project and attract more bidders, two major project requirements were broken out into separate Request for Quotations (RFQ): development of a tonnage and financial model; and baseline and best practice reports. These two projects will provide base data for future project phases and are in progress, with completion estimated in Q3 2023.

The tonnage and financial model is undergoing final staff review and will be used to analyze scenarios presented as potential options for consideration in the WMSP. Through a separate competitive process, a consultant was engaged in 2023 to develop a series of technical memos outlining expected baseline level of service and best practices in the industry, with a focus on comparator municipalities used in previous benchmarking memos and reports.

It is anticipated that the RFP for the remaining tasks/ phases, will be awarded in Q4 2024. The consultant will focus on supporting engagement with stakeholders at all phases, development of recommendations for short, medium, and long term options for innovative and effective program delivery, development of tools to measure success

and viability of potential actions, and generation of updated performance targets that align with legislative and regulatory changes affecting waste management. Appendix 1 provides a high-level list of activities for completion during the three phases.

Staff will continue to report on the WMSP progress to this Committee and will highlight opportunities for Councillor engagement throughout the multiple phases of the WMSP. Respectfully submitted and signed by
