BY-LAW NO. <>

A BY-LAW TO REMOVE A PORTION OF HIGHWAY
FROM THE REGIONAL ROAD SYSTEM IN THE CITY
OF WELLAND (RIVERSIDE DRIVE)

WHEREAS subsection 27 of the *Municipal Act, 2001*, S.O.2001, c.25, as amended, provides that a municipality may pass by-laws in respect of highway under its jurisdiction;

WHEREAS subsection 52(4) of the *Municipal Act, 2001*, S.O.2001, c.25, as amended, provides that The Regional Municipality of Niagara may remove a highway from its Regional Road system;

WHEREAS subsection 52(5) of the *Municipal Act, 2001*, S.O.2001, c.25 provides that where a highway is removed from the Regional Road system, such highway is thereupon under the jurisdiction of the lower-tier municipality in which the highway is located; and,

WHEREAS Regional Council deems it desirable to remove a portion of Riverside Drive between Regional Road 29 (Lincoln Street) and Regional Road 54 (Prince Charles Drive North), in the City of Welland, in the Regional Municipality of Niagara from its Regional Road system.

NOW THEREFORE the Council of The Regional Municipality of Niagara enacts as follows:

1. That the following lands be and the same are hereby removed from the Regional Road system:

A. R., PL 564 , PART 1 , 59R5126 ; PT LT 30, PL 556 , PART 2 , 59R5126 ; PT LT 29, PL 556 , PART 3 , 59R5126 ; PT LT 32, PL 556 , PART 1 , 59R3952 , S/T RO293415 ; PT LT H. A. R., PL 564 , PART 2 , 59R3952 ; PT LT 28, CON 5 CLD, PT LT 29, CON 5 CLD, PT RDAL BTN CONS 5 & 6 CLD, PT RDAL BTN LTS 28 & 29, CON 5 CROWLAND BEING PT 1 ON RO127599; WELLAND SAVE AND EXCEPT PT 3 ON 59R-17580 & SAVE AND EXCEPT PART 1 ON 59R-17579; BEING PART OF PIN 64102-0001 (LT)

SECONDLY:

PART LOT H.A.R. ON PLAN 564 DESIGNATED AS PART 2 ON 59R-17580;
WELLAND
BEING PART OF PIN 64101-0139 (LT)

THIRDLY:

PT LT 28 CON 5 CROWLAND, PT 2 59R12614; WELLAND
BEING ALL OF PIN 64102-0303 (LT)

FOURTHLY:

PT LT 28 CON 5 CROWLAND, PT 1 59R12614; S/T RO522714; WELLAND
BEING ALL OF PIN 64102-0301 (LT)

2. That this by-law shall come into force and effect on the day upon which it is passed.
