# 4.1 <u>2024 Proposed Niagara Transit Commission Budget (BRC-C 35-2023, Agenda Item 5.1))</u>

#### 4.1.1 Herb Sawatzky, 50by30Niagara

Herb Sawatsky, 50by30 Niagara, appeared before Committee to urge Committee members not to increase transit fares as a mitigation effort to reduce the 2024 Niagara Transit Commission budget, to reject the Niagara Transit Commission's request for a 5.7% levy increase and instead approve a transit levy increase of at least 6.7%.

### 4.1.2 Lindsay Taylor, St. Catharines Downtown Association

Lindsay Taylor, appeared before Committee on behalf of the St. Catharines Downtown Association, in support of the original 2024 budget proposed by the Niagara Transit Commission, and urging consideration for extending transfer times, creating partnerships with key stakeholders in the region and exploring creative funding solutions such as grants.

#### 4.1.3 Diane Foster, Resident, City of St. Catharines

Diane Foster, resident, City of St. Catharines, appeared before Committee to highlight the inefficiencies of the current specialized transit system, express concern with the proposed transit fare increase and encouraged Committee members to approve the Transit Commission's initial proposed budget in order to improve the system.

2024 Proposed Revised Operating and Capital Budget Submission and Requisition - Niagara Transit Commission

- 1. That Regional Council **APPROVE** the Niagara Transit Commission 2024 gross operating budget submission of \$82,246,767 and Special Levy of \$58,121,710 for an increase of \$3,068,760 or 5.57%, which net of assessment growth for 2024 reflects an overall 2024 budget increase of 3.91%; and
- 2. That the Special Levy of \$58,121,710 **BE APPORTIONED** between the local municipalities as determined in accordance with the methodology approved in PW 55-2021 and based on final 2023 current value assessment.

- 2. That the Special Levy of \$58,351,710 **BE APPORTIONED** between the local municipalities as determined in accordance with the methodology approved in PW 55-2021 and based on final 2023 current value assessment.
