A BY-LAW TO RENAME REGIONAL ROAD 61
(TOWNLINE STAMFORD ROAD / NIAGARA
TOWNLINE ROAD) TO REGIONAL ROAD 61
(NIAGARA TOWNLINE ROAD) BETWEEN REGIONAL
ROAD 100 (FOUR MILE CREEK ROAD / ST. PAUL
AVENUE) AND REGIONAL ROAD 102 (STANLEY
AVENUE) IN THE TOWN OF NIAGARA-ON-THE-LAKE
AND THE CITY OF NIAGARA FALLS

WHEREAS pursuant to subsection 28(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, the Regional Municipality of Niagara has jurisdiction over Regional Road 61 (Townline Stamford Road/Niagara Townline Road);

WHEREAS notice of this proposed by-law was published on The Regional Municipality of Niagara's website and in local newspapers (Lake Report and NOTL Local) in accordance with Niagara Region's Public Notice Policy and a public meeting was held at the Public Works Committee meeting on January 9, 2024;

WHEREAS Regional Council at its meeting held on January 25, 2024, adopted a motion (Report PW 1-2024) authorizing the enactment of a by-law to rename Regional Road 61 (Townline Stamford Road / Niagara Townline Road) to Regional Road 61 (Niagara Townline Road) between Regional Road 100 (Four Mile Creek Road / St. Paul Avenue) and Regional Road 102 (Stanley Avenue) in the Town of Niagara-on-the-Lake and the City of Niagara Falls.

NOW THEREFORE the Council of The Regional Municipality of Niagara enacts as follows:

1. That Regional Road 61 (Townline Stamford Road / Niagara Townline Road) between Regional Road 100 (Four Mile Creek Road / St. Paul Avenue) and Regional Road 102 (Stanley Avenue) in the Town of Niagara-on-the-Lake and the City of Niagara Falls, which is more particularly illustrated on the diagram attached to this by-law, is to be named Regional Road 61 (Townline Road).
