# 7. OTHER BUSINESS

## 7.1 <u>Emterra Environmental Update</u>

The Committee Vice-Chair advised that the Emterra Environmental Update was moved to the closed session portion of the meeting.

### 7.2 Road Design and Speed Limits

Councillor Steele requested staff consider the review of municipal roads and speed limits as part of the development process to ensure that existing roads are able to accommodate traffic increases and the speed limit is appropriate.

### 7.3 Road Safety Concerns

Committee members requested staff review road safety concerns in the following areas:

# Town of Fort Erie

- Off-ramp intersection from the QEW on Bowen Road
- Intersection of Burleigh Road North and Dominion Road
- Intersection of Farr Avenue and Elmwood Avenue

# Town of Niagara-on-the Lake

- Speed limit on Regional Road 55 (Niagara Stone Road) between Line 1 and Garrison Village Drive
- Installation of advanced left turn signal on Regional Road 55 (Niagara Stone Road) at East and West Line

### 7.4 Wastewater Treatment Plants, Town of Niagara-on-the-Lake

Councillor Zalepa requested staff provide information respecting vendors accessing Region wastewater treatment plants and if there are any vendors that are prohibited from delivering waste. Catherine Habermebl, Acting Commissioner, Public Works, advised that vendors may access the facilities during regular operating hours and arrangements could be made for access outside of those times and that there are no vendors that are currently prohibited. Vendors retained by the Region must provide proper documentation, including insurance and proof of Worker Safety Insurance Board (WSIB) coverage.

### 7.5 Long-Term Waste Management Planning

Councillor Zalepa requested that staff review options for environmentallyfriendly alternatives to landfills. Catherine Habermebl, Acting Commissioner, Public Works, advised that staff were reviewing alternative technologies and that a waste management strategic plan would be started in Q4 2019.

### 7.6 Water Main Break, Ontario Street, Town of Lincoln

Councillor Foster expressed concern with the lack of communication respecting the recent water main break on Ontario Street in the Town of Lincoln. Ron Tripp, Acting Chief Administrative Officer, apologized for the lack of communication to Councillors on this matter and advised that in the future those Councillors affected would be notified.

#### 7.7 <u>Pedestrian Safety Regional Road 38 (Martindale Road) and Regional</u> <u>Road 87 (Main Street), City of St. Catharines</u>
