8.2 <u>Motion Respecting Establishment of a High-Level Mental Health and</u> <u>Addiction Treatment Facilities with the Niagara Region - Funded by the</u> <u>Provincial Government</u>

Moved by Councillor Morocco Seconded by Councillor Insinna

WHEREAS communities across Ontario, including the Niagara Region, continue to experience a significant rise in individuals suffering from severe mental health issues and substance use disorders;

WHEREAS existing local supports and facilities are under-resourced and are often unable to provide the intensive, wraparound, long-term care needed for individuals with complex or chronic needs;

WHEREAS police services, emergency departments, local shelters, downtown businesses and the broader community are increasingly bearing the burden of responding to crises related to untreated or undertreated mental illness and addictions;

WHEREAS there is a clear and urgent need for a dedicated, professionally staffed facility within the region that can deliver an intensive care for both—comprising medical detox, and long-term residential treatment, psychiatric support, and reintegration services;

# NOW THEREFORE BE IT RESOLVED:

- 1. That the Council of the Niagara Region, formally **ADVOCATE** for the establishment of an intensive mental health and addiction treatment supportive housing program that includes 24-7 support as well as medication support for clients with complex needs;
- 2. That Council **CALLS** upon the provincial and federal governments to invest in the planning, funding, and staffing of such facilities to meet the growing needs of vulnerable populations in our community;
- 3. That staff **BE DIRECTED** to prepare a report identifying potential partnership opportunities with the Ministry of Health, Ontario Health, Niagara Health, community based clinical support services, mental health and addictions service providers, and supportive housing providers; and
- 4. That a copy of this motion **BE SENT** to Niagara's four MPs; Niagara's four MPPs; the Association of Municipalities of Ontario (AMO); the Federation of Canadian Municipalities (FCM); Mayors and Regional Chairs of Ontario (MARCO); Ontario's Big City Mayors (OBCM); and the Ontario and Canadian Associations of Chiefs of Police; The Ontario Ministry of Health, Ontario Health Mental Health and Addictions Centre of Excellence, the Ministry of Municipal Affairs and Housing; and Niagara Health.
