Subject: 2025 Public Realm Investment Program Funding Commitments

The purpose of this memorandum is to provide an update to the Planning and Economic Development Committee with respect to the 2025 Public Realm Investment Program (PRIP). This memorandum summarizes the funding commitments awarded this year. The program allows area municipalities (AMs) to make submissions for funding of public realm enhancement projects along regional roads. A description of each project is listed in a table in this memo.

Program Background

The Public Realm Investment Program began in 2016 to support AMs with matching funding to create attractive public spaces along regional roads. These public realm enhancement projects include streetscaping, street furnishings, civic gateways, urban plazas, active transportation facilities, public art and other public realm elements. AMs make project submissions that are evaluated against 32 criteria by a technical team of Regional staff. The maximum Regional funding contribution is \$150,000 per project and the minimum is \$25,000. The total allocations for 2025 is \$250,000.

Through the program, Area Municipalities (AMs) receive design support from the Region's landscape architecture and urban design team for the selected enhancement projects. This collaboration helps both AMs and the Region combine resources effectively, leading to higher-quality and more impactful public realm improvements.

Now in its tenth year, the program continues to build upon the successes of past years. The program has contributed to 38 projects to date and is consistently over-subscribed.

2025 Funding Commitments

On February 3, 2025, Regional staff distributed the PRIP Application Guide and Glossary to Area Municipality (AM) staff, inviting them to submit funding requests to the program by March 28, 2025.

Similar to previous years, the 2025 program was over-subscribed with total funding requests of over \$496,000. Staff received six (6) submissions from four (4) AMs.

Of the six (6) projects submitted, five (5) projects (Fort Erie, Grimsby, Niagara Falls, St. Catharines) will receive a funding commitment through PRIP. The remaining project (Grimsby) is at an early stage and not ready for assigned funding this year.

This year, the entire program budget has been assigned. The following table provides projects details and their assigned funding contributions:
