## BY-LAW NO. &lt; &gt;

A BY-LAW TO AMEND BY-LAW 2019-61  
BEING A BY-LAW TO PROVIDE FOR THE REGULATION  
OF TRAFFIC ON REGIONAL HIGHWAYS

---

WHEREAS section 214(1) of the *Highway Traffic Act*, R.S.O. 1990, c.H.8, as amended, provides that the Council of a municipality may by by-law designate a part of a highway under its jurisdiction as a community safety zone if, in the council's opinion, public safety is of special concern on that part of the highway; and

WHEREAS Regional Council passed By-law 2019-61 on July 18, 2019 designating specific community safety zones; and

WHEREAS Regional Council deems it advisable to designate additional community safety zones.

NOW THEREFORE the Council of The Regional Municipality of Niagara enacts as follows:

1. That Schedule "A" of By-law 2019-61 is hereby amended by adding the following as Community Safety Zones.
